Upon submitting the required information and fees to the Cosmetology Association of New Brunswick and subject to approval by the Registrar, you may be issued a temporary license for the province of New Brunswick. If your qualifications do not meet the standards for the province of New Brunswick, your application will be forwarded to the Examining & Licensing Committee for review.

If you qualify, the temporary license will be valid for three months, at an additional cost of \$30.00. During this time, you will be scheduled for an examination, which will be held in Fredericton, NB. You will receive notification of your examination at least (30) thirty days before your scheduled date. Information concerning your examination will be included with your notification.

I certify that the information contained herein is true, correct and complete with supporting documents attached. I understand that I cannot seek employment as a cosmetologist in New Brunswick without obtaining the required license. I have read the requirements and upon passing the required examination, I will abide by the Statutes of the Cosmetology Association of New Brunswick.
