Upon submitting the required information and fees, to the Cosmetology Association of New Brunswick and subject to approval by the Registrar, you may be issued a Work Permit for the province of New Brunswick. If your qualification does not meet the standards for the province of New Brunswick, your application will be forwarded to the Examining & Licensing Committee for review.

This Work Permit will be valid for three months only. During this time, you will be scheduled for an examination, which will be held in Fredericton, NB. You will receive notification of your examination at least (30) thirty days before your scheduled date. Information concerning your examination will be included with your notification.
