This year's Annual General Meeting is arriving quickly, don't miss your chance to submit your motions!

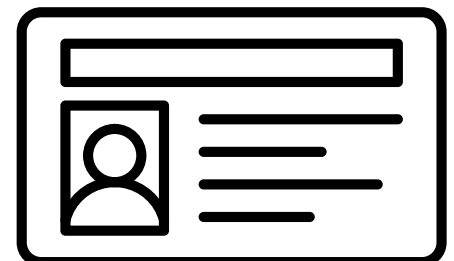
