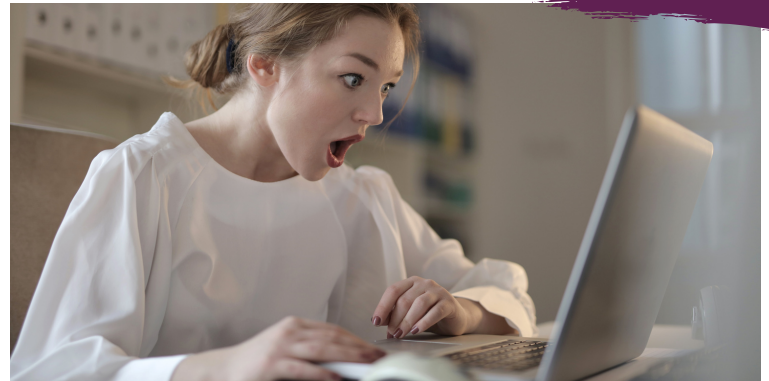
Don't miss the submission deadlines!

How to Present a Motion

Rules and procedures during an AGM can be confusing and hard to navigate. Knowing that, the CANB wants to ensure that its members have a better understanding of how to navigate through them effectively.

By adhering to the below procedures and guidelines, our members can effectively present their motions during this year's AGM.

1. Members must be in attendance to present motions during the Annual General Meeting (AGM);
2. Presenters should ensure that motions are clearly articulated and specific in their intent;
3. Motions must not be detrimental to the association's goals, values, or legal obligations;
4. The presentation of motions and their consideration during the AGM follows the guidelines outlined in "Robert's Rules of Order";
5. Motions cannot be proposed spontaneously during the meeting; instead, they must follow the formal process outlined in the rules.
