Upon successful review of your application, you may qualify for a temporary license, at an additional cost of \$30.00. This license will enable you to work as a cosmetologist in New Brunswick, temporarily, under the supervision of a licensed Cosmetologist with the CANB (in your same scope of practice), in a registered salon. A temporary license is valid for a maximum of three months. During this time, you will be scheduled for the Provincial examination or the by-law and Act exam, held in Fredericton, NB.
